

1. The Promoter

The promoter is: George Super TopCo LLC of c/o The Freehand New York, 23 Lexington Avenue, New York, NY 10010.

2. How to enter

2.1 The competition will run from 12PM on 17th April 2022 to 3PM on 17th April 2022 with 3 egg hunts starting at 12PM, 1PM and 2PM. Each hunt has its own prize.

2.2 To enter the competition, find the golden egg located somewhere in the North side of Broken Shaker on the rooftop of The Freehand New York (the "Hotel") and bring the egg to the Front Desk by the End Time.

2.3 By submitting a competition entry, you are agreeing to be bound by these terms and conditions.

3. Eligibility

3.1 The competition is only open to all registered guests of the Hotel on 17th April 2022, **except:**

- (a) employees of the Promoter or its holding or subsidiary companies;
- (b) employees of agents or suppliers of the Promoter or its holding or subsidiary companies, who are professionally connected with the competition or its administration; or
- (c) members of the immediate families or households of (a) and (b) above.

3.2 In entering the competition, you confirm that you are eligible to do so and eligible to claim the prize. The Promoter may require you to provide proof that you are eligible to enter the competition.

3.3 There is a limit of one entry to the competition per person.

3.4 The Promoter reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the competition.

4. The prize

4.1 The prize is 100 bars of Tony's Chocolonely chocolate bars and a 2 night stay during the week at one of the US Freehand properties (Freehand New York, Freehand Los Angeles, Freehand Chicago, and Freehand Miami) before the end of the year.

4.2 The chocolate is provided by Tony's Chocolonely in its sole discretion and may contain nuts, dairy and other allergens as set out on the packaging.

4.3 The hotel stays are room only and are provided by the Promoter or its group companies. The stays must be taken before the end of 2022 and are only valid on weeknights (no weekends). All dates are subject to availability at the time of request. The prize does not include travel insurance, travel to and from the hotels, food and drink, spending money, tax or personal expenses. Any other costs incurred in addition to those set out above and that are incidental to the fulfilment of the prize are the responsibility of the winner(s).

4.4 You will be responsible for ensuring that you and any person travelling with you are available to travel and hold valid passports, any necessary visas and travel documents for the stays in question on the travel dates specified.

4.6 The prize is not negotiable or transferable.

4.8 The Promoter does not accept any responsibility if you are not able to take up the prize.

5. Winner

5.1 The decision of the Promoter is final and no correspondence or discussion will be entered into.

5.2 The winner will be announced on site after the end of each egg hunt by the Freehand NY staff.

6. Limitation of liability

Insofar as is permitted by law, the Promoter, its agents, group companies, directors, shareholders, employees and contractors will not in any circumstances be responsible or liable to compensate the winner or any participant in the competition and do not accept any liability for any loss, damage, personal injury or death occurring as a result of participating in the competition or taking up the prize except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees.

7. Ownership of competition entries and intellectual property rights

7.1 By taking part in the competition, you consent to the Promoter filming (whether still or video) your participation in the competition and making photos and/or footage available on the Freehand, and Tony's Chocoloney's, website and social media channels and including the same in press releases and publicity materials. 9.3 These terms and conditions shall be construed and enforced in accordance with the laws of the State of New York (without taking into account its conflicts of law provisions) and the parties submit to the exclusive jurisdiction of the courts of the State of New York.
